



TO PROHIBIT A BUDGET GIMMICK

SEC. ____ . SENATE POINT OF ORDER AGAINST PROVISIONS OF APPROPRIATIONS LEGISLATION THAT CONSTITUTE CHANGES IN MANDATORY PROGRAMS AFFECTING THE CRIME VICTIMS FUND.

(a) IN GENERAL.—In the Senate, it shall not be in order to consider any appropriations legislation, including any amendment thereto, motion in relation thereto, or conference report thereon, that includes any provision or provisions affecting the Crime Victims Fund, as defined by 42 U.S.C. 10601, which constitutes a change in a mandatory program that would have been estimated as affecting direct spending or receipts under section 252 of the Balanced Budget and Emergency Deficit Control Act of 1985 (as in effect prior to September 30, 2002) were they included in legislation other than appropriations legislation. A point of order pursuant to this section shall be raised against such provision or provisions as described in subsections (d) and (e).

(b) DETERMINATION.—The determination of whether a provision is subject to a point of order pursuant to this section shall be made by the Committee on the Budget of the Senate.

(c) SUPERMAJORITY WAIVER AND APPEAL.—This section may be waived or suspended in the Senate only by an affirmative vote of three-fifths of the Members, duly chosen and sworn. An affirmative vote of three-fifths of the Members of the Senate, duly chosen and sworn, shall be required to sustain an appeal of the ruling of the Chair on a point of order raised under this section.

(d) GENERAL POINT OF ORDER.—It shall be in order for a Senator to raise a single point of order that several provisions of a bill, resolution, amendment, motion, or conference report violate this section. The Presiding Officer may sustain the point of order as to some or all of the provisions against which the Senator raised the point of order. If the Presiding Officer so sustains the point of order as to some of the provisions (including provisions of an amendment, motion, or conference report) against which the Senator raised the point of order, then only those provisions (including provision of an amendment, motion, or

conference report) against which the Presiding Officer sustains the point of order shall be deemed stricken pursuant to this section. Before the Presiding Officer rules on such a point of order, any Senator may move to waive such a point of order as it applies to some or all of the provisions against which the point of order was raised. Such a motion to waive is amendable in accordance with rules and precedents of the Senate. After the Presiding Officer rules on such a point of order, any Senator may appeal the ruling of the Presiding Officer on such a point of order as it applies to some or all of the provisions on which the Presiding Officer ruled.

(e) FORM OF THE POINT OF ORDER.—When the Senate is considering a conference report on, or an amendment between the Houses in relation to, a bill, upon a point of order being made by any Senator pursuant to this section, and such point of order being sustained, such material contained in such conference report or amendment shall be deemed stricken, and the Senate shall proceed to consider the question of whether the Senate shall recede from its amendment and concur with a further amendment, or concur in the House amendment with a further amendment, as the case may be, which further amendment shall consist of only that portion of the conference report or House amendment, as the case may be, not so stricken. Any such motion shall be debatable. In any case in which such point of order is sustained against a conference report (or Senate amendment derived from such conference report by operation of this subsection), no further amendment shall be in order.



(1) which proposes a change or changes to law that the Congressional Budget Office determines has an outlay impact in excess of 0.25% of GDP during the first decade or in the tenth year; or

(2) with respect to which the chair ~~or ranking member~~ of the Committee on the Budget of either the Senate or the House of Representatives has requested an estimate described in subsection (a).

To Require Accurate and Complete Reporting on Tax Expenditures By the Congressional Budget Office

Sponsor: Senator Angus S. King, Jr 2

Purpose: To require accurate and complete reporting on tax expenditures by the Congressional Budget Office.

Background: While the Congressional Budget Office, the Office of Management and Budget, and the Joint Committee on Taxation all publish lists or estimates of federal tax expenditures on an annual basis, none provide both long-term estimates (10 year estimates) and historical data on federal tax expenditures as a percentage of gross domestic product. By requiring the CBO to publish this data in its annual *Budget and Economic Outlook* report, lawmakers will have a better understanding of the growth in federal tax expenditures alongside more transparent forms of federal spending.

Existing Data on Tax Expenditures

- The Congressional Budget and Impoundment Control Act of 1974 requires the Congressional Budget Office and the Treasury to annually publish lists of federal tax expenditures.
- The Act also requires OMB to list tax expenditures as part of the President's budget request; that list can be found in the *Analytical Perspectives* section.
- The Joint Committee on Taxation publishes an annual report on five year estimates of tax expenditures.


