


"Climate-induced temperature changes will have dramatic impacts on human life.



THE SENATE BUDGET COMMITTEE WILL HOLD A HEARING WEDNESDAY FOCUSING ON GLOBAL WARMING'S CONSEQUENCES ON HEALTH CARE COSTS.

THE HEARING — THE SIXTH DEALING WITH CLIMATE FROM THE COMMITTEE THIS YEAR — IS TITLED "UNDER THE WEATHER: DIAGNOSING THE HEALTH CARE COSTS OF CLIMATE CHANGE." THE PANEL WILL EXPLORE THE ISSUE FROM THE PERSPECTIVE OF "WORKERS, FAMILIES AND THE FEDERAL BUDGET," ACCORDING TO A PRESS RELEASE FROM THE COMMITTEE ANNOUNCING THE EVENT.

"CLIMATE CHANGE IS CAUSING HIGHER TEMPERATURES, MORE EXTREME WEATHER EVENTS, FLOODING IN SOME AREAS AND SEVERE DROUGHT IN OTHERS, AND MORE INTENSE WILDFIRES—ALL OF WHICH AFFECT PUBLIC HEALTH OUTCOMES," THE PRESS RELEASE READS.

"WITH HIGHER RATES OF CARDIOVASCULAR AND RESPIRATORY DISEASE NATIONWIDE, AND BETWEEN DOCTOR'S APPOINTMENTS, EMERGENCY ROOM VISITS, PRESCRIPTION DRUGS, AND REHABILITATION AND HOME HEALTH SUPPORT, THE COSTS OF CLIMATE-RELATED HEALTH CARE ARE ESTIMATED TO TOP \$820 BILLION ANNUALLY."

UNDER COMMITTEE CHAIR SHELDON WHITEHOUSE (D-R.I.), EARLIER HEARINGS HAVE FOCUSED ON THE CLIMATE IMPACTS ON HOUSING MARKETS AND FLOOD INSURANCE, THE COSTS OF WILDFIRE MITIGATION AND RECOVERY AND THE STABILITY OF THE FOSSIL FUEL INDUSTRY.
